Trustee Reardon asked how the bidding process for the properties for sale will be publicized. Administrator Vaughn suggested using the Township website and maybe some publication of a public notice.

Trustee Cera requested a review of grants that have been awarded this year and the potential for future Ohio Public Works Commission projects.

Administrator Vaughn reviewed an Ormond Ave project that was awarded was about \$219,000 and Elmore Ave that should wrap up soon is about \$40,000, both were awarded before 2019. For upcoming applications the Township might apply for drainage and re-paving because those types of projects often score better than things like sidewalks.

Fire Chief Fraley reviewed that his department recently received \$10,000 for safety gear, \$3,000 has been applied for EMS training equipment, the department also applied for a Firehouse subs grant that would cover equipment at \$22,000.

Police Chief Jones reviewed that his department was awarded \$1,000.00 from OTARMA to cover policy needs, DUI Task Force has awarded \$3,500.00, a public safety grant for \$8,000.00 would be for equipment, and a traffic safety grant for \$20,000.00.

Trustee Cera added that the Township recently received a \$1,125 grant from Franklin Soil and Water for landscaping with native perennials at the two new parks.
