Fiscal Officer Steele read the December 2019 Fiscal Report. On Dec. 1^{st,} there was an overall Fund Balance of \$5,517,835.32 there was \$382,745.91 in Revenue and \$524,982.53 in Expenditures leaving an overall Fund Balance on December 31st, 2019 of \$5,375,596.70.

There was discussion about the list of uncleared checks and efforts to connect with the vendors who might need to have a payment reissued.

There was discussion of neighborhood signs for parks and Township buildings. Trustee Sword asked Trustee Cera what sort of new signs are being considered, and Cera responded that she does not have any preconceived ideas but would like residents to give input. Resident Carol Stuart asked about the old sign that was in front of 999 Chambers Rd, that she is hopeful it could be repurposed and was created with a 1940's type theme. Ms. Stuart and her husband would volunteer to help cut the old sign for a new use. Trustee Cera added that there has been discussion about benches, and trash cans, and that a conversation needs to be had to discuss placement of the sign and of all these items. Superintendent Fleig is willing to work with folks and map out ideal placements. Resident Jane Margiotta wanted to know if there was a meeting or discussion before removing the old sign at 999 Chambers Rd. The Board responded that they recall ordering signs and the overall need to update signs. Trustee Reardon asked where the old building sign is for 3820 Cleveland Ave, and was informed it is in a garage at that location. Resident Nick Gani stated that the UVCA paid for the old sign at 999 Chambers Rd. Fiscal Officer Steele added that the Civic Association donated the sign to the Township, and at that point the sign is the Township's property.

Resident and former Trustee Paula Armentrout is upset about trash that has been left for several weeks at 1997 Radnor Ave. She stated that a flyer was created with the county on Economic Development that listed things like where people can dump old furniture, but she has heard that the Township is not collaborating anymore with other agencies. Trustee Cera said that she recalls being in the audience when Ms. Armentrout faced the exact same frustrations on the Board, and that this is not something new and it is an ongoing problem. There was confusion about how the Township could become a Limited Home Rule jurisdiction, Ms. Armenrout accused the Board of not moving forward with this process and the Board responded that they cannot do so, that it is up to residents. The went on to say this recently came up at a previous meeting and they directed residents to connect with the Franklin County Board of Elections to learn how this could be brought to the voters of the Township to decide. Trustee Reardon added petitions presented to the board should be made in an open meeting and be reflected in the minutes.

POLICE

Sergeant Newman was Awarded the Officer of the Year by Trustee Sword. This Award is given to the Officer or Supervisor who was nominated by his or her peers. Sgt. Newman has promoted and managed several of our Community commitment campaigns such as the annual, Heroes' and Helper's program with Target, AMC, Bath and Body Works, and Infinity 99 cent stores. Over 30 Families were assisted this past Holiday season. Sgt. Newman also assist's in Picnic with Police and working with juvenile programs with the Police Department. Sgt. Newman also takes pride in making sure new officers are welcomed when coming aboard and setting up the Field training program for them. Sgt. Newman always shows initiative and positive interaction with his fellow officers during his tours of duty. For this reason, Sgt. Newman was Awarded the Officer of the Year for 2019.

TOWNSHIP ADMINISTRATOR

Administrator Mr. Vaughn updated everyone that the Ohio Dept of Agriculture will be holding a meeting Feb 10th at 3820 Cleveland Ave from 6 till 8pm for the purpose of relating to their <u>Gypsy Moth Management Program</u>.

Mr. Vaughn also provided the monthly Code Compliance report. There was some discussion about the mini 5G Sprint cell phone towers that are going up more on the Westside and likely they will be attached to existing poles.

Resident Jane Margiotta asked if this new equipment will be able to travel to the Westside to do work and Mr. Fleig responded, yes it is smaller than the backhoe.

Mr. Fleig provided a January monthly report. <u>OTHER ITEMS</u> Resident Carol Stuart asked if the broken residential stove at 999 Chambers Rd is going to get replaced, officials said they would look into it.

Resident Tony Gossman asked why both meetings of the month have been moved to Noon. He was aware that some folks work 2nd shift so maybe this would fit their schedule better but for the 9am to 5pm folks it does not. There was a review of when other government bodies meet, and some Townships change the time of their meetings in the month. Fiscal Officer Steele added that it is possible residents could meet with a Trustee on a Saturday if that fits their schedule better. Mr. Gossman also had questions about property taxes and there was clarification of how departments are funded. It is common that residents are not aware the vast majority of their real-estate taxes fund Columbus Public Schools.

Resident Nick Gani added that the entrances into the playground would benefit from being paved over, or asphalt added. There is concern about public easements and being sure water drainage is attended to, but Superintendent Fleig will look into it.

Trustee Cera added that AEP will soon start adding electric streetlights on Walford and Elmore on existing poles.

Resident Bobbie Olt asked why the Township issued cell phones are not listed on the website. The Board responded that many websites get phone and emails hacked and then they get many robocalls and junk mail so a "contact us" form is on the website instead.

Information Specialist Rachel Adams announced that the <u>OTA conference</u> is happening this week and many officials and staff are participating from the Township.
