A Special Meeting of the Clinton Township Board of Trustees was held on March 20^{th,} at 2pm at 3820 Cleveland Ave. Present were Trustees Jane Cera, Carl Reardon, and Aliena Sword, Fiscal Officer Deb Steele, Fire Chief Fraley, Police Chief Jones, Superintendent Fleig, and no residents in person, however there was a live video feed online.

GENERAL

Res. No. 20-03-016 Motion by Trustee Sword to approve the 2020 Permanent Appropriations. 2nd Trustee Reardon. Vote: Trustee Reardon, Trustee Cera – Yes, Trustee Sword – Yes

Trustee Cera thanked everyone for using their "other" line items less over the years. Trustee Sword appreciates the departments represented by color, such as blue for Police funds. There was a short discussion about a reduction in Real Estate taxes and Income taxes as a result of the Coronavirus 19 outbreak. Trustee Reardon was wondering if folks will get behind on their mortgage payments, resulting in delinquent Real Estate revenues for the Township in the future. The Fiscal Officer added that more quickly the Township will likely see a reduction in the CEDA/JEDZ revenues, and all Departments should tighten their fiscal belts where they can. Overall the Township is not appropriating to the max allowed amounts. Trustee Cera added that the Township is tracking expenses that are a result of the virus outbreak and may be reimbursed at some point in the future.
