There will be a Veterans Day Ceremony Nov 11th at 3856 Walford St at 10:45am.

Administrator Huffman brought forward discussion about rental of Township spaces. An outdated rental agreement has been reviewed and some comparisons to other Township rental agreements have been made. Trustee Cera recalled concerns that if the Twp rents to one group that any group could request to rent Township spaces. How late a space would be available is a concern. Trustee Cera said Police and Fire personnel should not be in evening custodial roles and was concerned about staffing evening events. Fiscal Officer Steele added that other governments use the Community Room, and she was looking for a Building Use Policy before exploring rental agreements. Trustee Cera reminded that one of the original purposes of the room was to have a Clinton Township list of recreational offerings scheduled by the Twp for residents. Trustee Grimm likes the idea of using the space for Educational and Training opportunities. Admin Huffman will put something together to review.

There was a review of possible employee handbook revisions. The current handbook was written by a different legal team. Trustee Cera asked how many revisions are needed. The Fiscal Office offered to assist until a revision would be ready for an attorney review. Trustee Cera said that recent updates should surely be included, and necessary clarifications made, but that this should not be a re-invention of the entire manual so recently paid for by the Board. She applauded Mr. Huffman for wanting to put in place a process for when revisions are made.

Administrator Huffman has not been hearing back from contractors as to adding a Carport for the Police Cruisers.
