The Meeting of the Clinton Township Board of Trustees was held on January 5<sup>th</sup> at 6:30 p.m. at 3820 Cleveland Ave and <u>broadcasted</u> online. Present were Trustees Jane Cera, Jessica Jessberger, and Rebecca Grimm, Fiscal Officer Deb Steele, Township Administrator Matt Huffman, Fire Chief Fraley, Police Chief Jones, Public Works Superintendent Dave Medley, Community Affairs Specialist Deborah Smothers, and several residents.

#### **GENERAL**

Fiscal Officer Steele opened the meeting. Trustee Jessberger nominated Trustee Jessberger as Chair of the Board for 2023.

Trustee Cera said that the meeting is under Robert's Rules so a 2<sup>nd</sup> for a nomination is not needed. The Fiscal Officer did not agree that the Township operates under Robert's Rules. Trustee Cera replied that in fact, yes, we do. Trustee Grimm who was anticipating becoming the Chair expressed her surprise that she was not being considered. Fiscal Officer Steele said she was not sure what to do and asked Trustee Cera to choose who she would support to become the Chair and Trustee Cera said she was supporting Jessberger, but that since there were two nominees a vote could be taken with each Trustee saying the name of the person they vote for. There was a discussion about why Public Works would need this proposed transfer. There was discussion if the Road and Bridge Fund should pay for repaving projects. The Fiscal Officer added this was not to cover infrastructure improvements, that in 2022 the Road and Bridge Fund had several unplanned expenses such as the backhoe and some of the salt barn construction. Trustee Cera asked the other two Trustees what their thinking was when passing the last budget since she could not be in attendance. There was a general notion that road resurfacing needed to be done. Trustee Cera said there is already a significant balance in Road and Bridge and wondered what amount that was truly necessary. There was agreement that Mr. Medley would bring more information to the next meeting.

#### COMMITTEE/TEAM REPORTS

Fire Chief Fraley updated everyone that the next Free Produce market will be Friday, January 28<sup>th</sup> at 4pm at 3820 Cleveland Ave. Trustee Jessberger added yearly CHAT Anti-Violence focus. Trustee Cera reported that she had called Local Waste a few weeks ago regarding trash service leaving the can in the middle of the road and/or apron of her driveway and other residents.

#### TOWNSHIP ADMINISTRATOR

Admin Huffman provided a monthly report and proposed changes to the Inclement Weather policy whereas a Dept. Head could make the determination for staff to report to work. Trustee Cera would prefer the Chair to make that decision. Next, was a discussion regarding the Employee Handbook regarding adding language about the part-time and full-time health insurance coverage offered by the Township. Lastly there was discussion regarding the Cleveland Ave. signage project to start in 2024 and the language on the signs. This project would include medians, thus reducing the number of left turns. Trustee Jessberger stated she likes history and would like to incorporate Northern Lights history. Ideas for signs will be placed on the next agenda as well. Trustee Cera then asked Deborah Smothers to research historical markers. A reminder of the Ohio Township Association (OTA) upcoming conference is  $25^{\text{th}} - 27^{\text{th}}$  and registration ends on the  $10^{\text{th}}$ .
