The Meeting of the Clinton Township Board of Trustees was held on May 18th at 6:30pm at 3820 Cleveland Ave and broadcasted <u>online</u>. Present were Trustees Jane Cera, and Jessica Jessberger, Fiscal Officer Deb Steele, Township Administrator Matt Huffman, Fire Chief Brian Fraley, Police Chief Jones, Superintendent Medley of Public Works, Community Affairs and Public Relations Specialist Deborah Smothers, and some residents.

GENERAL

Res. No. 23-05-010 Motion by Trustee Jessberger to approve the agenda with flexibility. 2nd by Trustee Cera. Vote: Trustee Cera – Yes, Trustee Jessberger – Yes

Trustee Jessberger announced it is National EMS Week May 21st till May 27th, where emergency care begins. This was started in 1974 by President Ford. We thank Clinton and the nearby EMS Departments. It is also National Public Works Week, a time to celebrate the efforts of maintaining our public places and roadways.

Trustee Cera shared a list of ideas that were emailed in 2017 to Trustee Reardon about what the Beautification efforts could include. Some of the items had happened such as awarding plaques to homes. Trustee Grimm arrived about 6:40pm, she had a draft of what the efforts were in Springfield Ohio when they began in 1965. Trustee Cera lifted up that some of the items listed would require more than a volunteer effort from neighbors.

There was a discussion about Economic Development and the Township utilizing the <u>two</u> recent <u>studies</u> done. Trustee Cera would like to see businesses involved in some Focus Groups and reached out to Bill LaFayette to see if he would be available as a Consultant for the Township, and he is. Trustee Jessberger asked about the issue of Gentrification, Trustee Cera responded that the East side of the Township should benefit from new jobs coming to the area. Trustee Grimm asked if there are any examples of what kind of surveys would go out to businesses, and how to better build up community groups. The Board will review items and connect again about the effort.
