The Meeting of the Clinton Township Board of Trustees was held on Jan 23<sup>rd,</sup> at 6:00pm at 3820 Cleveland Ave and was broadcasted <u>online</u>. Present were Trustees Jessica Jessberger, and Rebecca Grimm, Fiscal Officer Deb Steele, Fire Chief Brian Fraley, Police Chief Jones, Superintendent Medley of Public Works and Administrator, Community Affairs and Public Relations Specialist Deborah Smothers, and some residents.

#### GENERAL

The next meeting will be February 13<sup>th</sup> 2024 at 999 Chambers Rd at 6pm

Motion by Trustee Grimm to approve the agenda with flexibility.  $2^{nd}$  by Trustee Jessberger. Vote: Trustee Grimm – Yes, Trustee Jessberger – Yes

Community Affairs and Public Relations Specialist Deborah Smothers said that Feb 1<sup>st</sup> is Ohio Township Day and the Township Hall will be open for visitor's who might want to see the Township.

There was discussion about having only one meeting in the summer months of June, July, and August. As the Board gets closer to these months they might modify the schedule of Board Meetings. It seems likely the Dec 24<sup>th</sup> meeting will not be needed, but again the Board will wait until it is closer to that time to decide if it should be cancelled.

## **FISCAL**

Fiscal Officer Steele read the December 2023 Fiscal Report. On Dec 1<sup>st</sup> the Township had an overall fund balance of \$9,935,899.86 with \$141,574.76 in Revenue and \$568,471.40 in Expenditures leaving a balance of \$9,509,003.22 on Dec 31<sup>st</sup>.

There was discussion with the Board about how they would like to pay off the TWP's portion of an Ohio Public Works Commission project that was completed last year on Walford for about \$81K. The TWP could take up to 10 years, paying at least 10% a year at zero interest. The Board reviewed that there is no penalty for paying off the loan in full on future applications with OPWC and they supported paying the loan in full before the end of the month.

There was discussion about establishing an Energy Special Improvement District within the TWP to allow for Property Assessed Clean Energy financing on commercial properties. There was confusion if this could be allowed on residential properties as well. The Fiscal Officer explained that if the TWP is going to move forward with installing things like solar panels PACE would allow the TWP to put the cost on a property bill that would have a 20 year long term loan and a better rate than what is being offered in most private loans. Trustee Grimm responded that we are lucky to have a forward thinking TWP for considering things like a microgrid and she is excited about this potential. Administrator Medley mentioned that Mid-Ohio Regional Planning Commission offers some home energy efficiency services as well.

### **COMMITTEE/TEAM REPORTS**

At a recent market 11K pounds of food was given to 491 people. The next such market will be Jan 26th from4pm till 6pm, and the line starts around 2:45pm at 3820 Cleveland Ave. There are more resources the 2<sup>nd</sup> market of the month, volunteers arrive around 3pm.

### COMMITTEE/TEAM REPORTS CONTINUED

Trustee Jessberger was proud to deliver Fire Chief Fraley an award in recognition of the Community Health Action Team's efforts. Franklin Co. Public Health provided a grant to continue the CHAT programing such as Women's Self Defense classes, public Movie Night, and Minority Health Month in the amount of about \$11K. The TWP is always seeking volunteers who might want to get more involved.

### **ADMININSTRATION**

Motion by Trustee Grimm to authorize Dave Medley to sign the agreement with Franklin Co Board of Elections to use the Township's facility at 999 Chambers Rd for a polling location. 2<sup>nd</sup> by Trustee Jessberger. Vote: Trustee Grimm – Yes, Trustee Jessberger – Yes

Trustee Grimm asked about the TWPs building use policy. The Board of Elections uses a waver for liability needs, the CHAT also has a waver they have used for the Women's Self Defense classes.

There was discussion on the Community Room's Audio-Visual equipment at 3820 Cleveland Ave. Staff is not able to use the wired microphone system to hear better for those attending and for the recordings on YouTube. It is possible the TWP might need to buy a better sound system as it has not worked well for most the time Administrator Medley has worked in the TWP and he would like to seek a professional opinion about the existing microphone system.

There was discussion about the next issue of the newsletter. The TWP will continue to encourage folks to sign up for an emailed version of the newsletter. Trustee Grimm suggested an article about how households can compost instead of bringing all their leaves to the curb. Community Affairs and Public Relations Specialist Deborah Smothers is learning more about Quick Response codes and how they might be used in future editions, such as linking or directing readers to Franklin Co Soil and Water Conservation District resources.

The TWP was approached by Archer Energy about the TWP approving an Opt-in energy aggregation program. In the past the TWP has always encouraged folks to compare their energy provider options on the <u>Apples to Apples</u> site. Sales people who knock on doors need to have a traveling vendor permit filed with the TWP, Police Chief Jones requested that the TWP look into an online payment option for vendors.

The meeting of the Joint Economic Development Zone Board meeting tomorrow, January 24<sup>th</sup> at 9:30am at 3820 Cleveland Ave has been cancelled and they plan to meet in February.
