

TRANSIENT VENDOR

- 1.) All persons or entities wishing to engage in any temporary selling activity shall apply for a permit except auction/auctioneer companies, garage sales of less than three (3) families all of whom are Clinton Township residents; and tax exempt organizations who give prior notice along with its tax organization number.
- 2.) A \$50.00 non-refundable application fee shall be provided when submitting a transient vendor application. Permits will be approved by the Chief of Police.
- 3.) Permit(s) granted shall be valid for ninety (90) days after date of issuance.
- 4.) Selling activities are permitted only from the hours of 8:00 a.m. to 8:00 p.m. Monday through Saturday and 10:00 a.m. to 5:00 p.m. on Sunday.
- 5.) All vendors must obtain all licenses, franchises or permits necessary to comply with local, state and federal requirements.
- 6.) Clinton Township reserves the authority to refuse, revoke, or cancel any permit at any time.
- 7.) Any vendor who fails to comply shall be guilty of a minor misdemeanor and shall have the permit revoked.
