"Being at the table as the Township's liaison to the JEDZ Board and MORPC will provide us with the opportunities for more collaboration and input which will assist in securing any available resources for future township improvements and overall residential benefits, such as the Metropolitan Transit Plan - MORPC Metropolitan Transportation Plan (MTP) -MORPC.org."

Trustee Clark and Daisy

Trustee Clark's priorities for the Township include revisiting the latest resident survey results as to resident priorities or concerns, determining ongoing issues and changing needs, then help create viable solutions. Also, "Most of the time we find that although we share information often and there are many resources available to help assist our residents, on our website that many residents are completely unaware. This may be because they do not have access to social media or our website. Residents can feel free to also call our office at 614-471-1479 regarding any requests, comments, or concerns." Trustee Clark said. "In addition, this summer, we are establishing communication boards at all of our parks. Information on Township events, updates, and resources will be posted accordingly and is just another way for residents visiting the parks to stay connected!"

Besides hanging with his Bichpoo Daisy, Trustee Clark enjoys traveling to visit his adult children, photography, landscaping his yard and renovating his home.

Dave Medley became our newly appointed Township Administrator in January 2024 and is currently serving the Township in his Public Works Superintendent role, which includes training and overseeing the Roads staff, and providing ongoing township services. Dave, who has 26 years of working in the public sector, is looking forward to collaborating with the Trustees to help make the community a better place to live and work. Smoothly implementing ongoing Township initiatives such as the upcoming Roads improvement projects are a main goal for Dave. Here are a few updates:



Cooke Rd project: The Franklin County Engineer's Engineers office is waiting for ODOT's approval on FEC's responses to Cooke Rd public comments we received. Once they receive their approval they will post responses on their website next to the issued Public Involvement documents. The goal is to award the Cooke Rd Improvement project in Fall 2025 with construction beginning in Spring 2026. Utility relocation work will begin in Fall 2024, starting with AEP relocating all utility poles located on the north side of Cooke Rd between Karl Rd and Walford St. Columbia Gas will also have sig- Dave Medley nificant relocation work on the south side of Cooke Rd that will take place prior to Spring 2026.

The Cleveland Avenue Safety Improvement Project:- This has been expanded to the south include the intersections of Dunbar/Piedmont/ Dunedin side streets. Previously the southern limits of the project were at Huy Rd. The northern limits of the project remain at Cooke Rd, with resurfacing planned as far north as Ormond Ave. The goal for FCE is to award Cleveland Avenue Safety Improvement project in July 2024. The contractor may begin construction late this summer or, more than likely due to the lead time it takes to acquire the overhead mast arms for the mid-block pedestrian crossing signage, they may start in Spring 2025. Columbus advised that their similar project to the south on Cleveland Avenue experienced 40+ week lead times on this material. They don't want the contractor to start construction late this summer if they cannot also finish the project before winter.

Dave is also involved with the various MOPRC initiatives as well as working with the City of Columbus' Linden Green Line Park Project which will provide a new trail and park space for the Linden and Northland community. https://columbusrecparks.com/connect/about/ capital-improvement-projects/linden-green-line/

CTDF AWARDED \$14,000 GRANT!

Over the last few years many organizations have conducted studies related to cancer in the fire service. These studies have shown that firefighters risk an increase in developing various types of cancers due to the exposures to smoke and other toxic gases. The Clinton Township Division of Fire was one of the first departments in Franklin County to develop a Cancer Reduction Policy. The new station was built with a decontamination corridor that allows our firefighters to immediately remove contaminated clothing and shower before entering the station. According to the Ohio BWC, this was the first firefighter decontamination corridor in Ohio. PREVENT CHILDHOOD LEAD POISONING



Many homes built before 1978 contain lead-based paint. This paint can cause serious health problems for children.

- Free home renovations are available to those who qualify.

Many other departments have since followed suit. The Clinton Township Division of Fire was recently awarded \$14,000.00 from the BWC Firefighters Exposure to Environment Elements Grant (FEEEG). This grant covers the cost of 80 particulate blocking hoods that reduce smoke penetration to the skin and 50 pairs of washable FI fire gloves. This grant will cover the cost of these needed items for the next few years.

- \cdot Checking vehicles FIRST if a child goes missing.

 \cdot Dial 911 immediately if you see an unattended child/animal in a parked car if there are no signs of an air conditioner cooling the interior.

mail system. You may also email Dan Quigley, Code Compliance Officer, at dquigley@clintontownship.org. We greatly depend upon the assistance of residents to report any code violations and you may report anonymously; just scan the QR code for direct access to the form!

COMMON CODE VIOLATIONS **High Grass and Weeds**



High grass and weeds can quickly become a fire hazard as well as a breeding place for mosquitoes and rodents. Grass or weeds higher than 10 inches are not in compliance. Once reported or we are made aware, one has only 7 days to remove the high grass and weeds. If the problem is not resolved after allowed time period for abatement has expired, legal action is then taken in Environmental Court!

Abandoned and Junked Vehicles

Junked vehicles visible from a public place or public rightof-way are detrimental to the safety and welfare of the general public, tend to reduce the value of private property, invite vandalism, and harm the economic welfare of the Township!

Typical violations of this ordinance include accumulation of trash, wood debris, building and fencing materials, furniture, appliances, tires, car parts, tree limbs, and other related materials. Residents are asked to call Local Waste for bulk pick up, if applicable and to not set out until the pick up. If the problem is not resolved, legal action is then taken in Environmental Court.

Trash, Rubbish and Open Storage

Typical violations of this ordinance include accumulation of trash, wood debris, building and fencing materials, furniture, appliances, tires, car parts, tree limbs, and other related materials. Residents are asked to call Local Waste for bulk pick up, if applicable and to not set out until the pick up. If the problem is not resolved, legal action is then taken in Environmental Court.

BRUSH PICK UP BEGINS April 8th!



The winter season has guickly come and gone (hopefully!). Although we did not have much snow plowing this year, street maintenance will be soon underway to remedy all those cracks and potholes. Chippy the Chipper is also looking forward it get out and eat some brush now!

The Public Works crew will begin brush collection April 8th, every Monday and Tuesday, and will continue until the end of October. Remember to:

- Place brush near the street with cut \Rightarrow ends pointed toward the street.
- Leave limbs and small trees in one \Rightarrow piece.
- Leave bundles loose. Do not tie. \Rightarrow
- Put roots out for trash collection. \Rightarrow
- Remove items such as wire, string, \Rightarrow rope, Christmas decorations, plastic or paper. These items can damage the chipper.
- Put yard waste such as grass clip-pings, hedge trimmings, fruit vines, weeds and leaves in yard waste bags \Rightarrow and put out for trash pickup.
- \Rightarrow Also remember that brush hauled onto property or left by professional trimmers will not be picked up.
